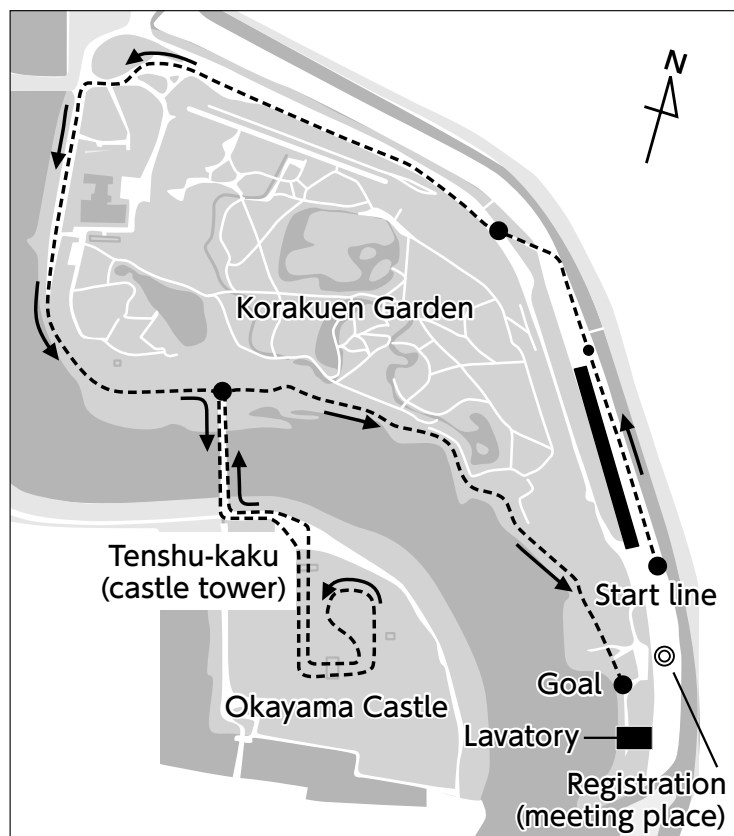

### 【Course】

about 3 km in length, the course follows the outskirts of Okayama Korakuen Garden and includes part of Okayama Castle (Korakuen east side, Asahikawa riverbank, Korakuen west side, Tsukimi Bridge, Okayama Castle Tenshu-kaku, Tsukimi Bridge, Korakuen south side, goal).

## Rules

As a participant in the Morning Run organized by the 53rd Annual Meeting of the Japan Diabetes Society 2010, I agree to:

1. Be responsible for my own health and accept full responsibility for any injury, illness, accident, loss of personal belongings, etc. that might occur during or as a result of the Morning Run event.
2. Obey the instructions of the 53rd Annual Meeting of the Japan Diabetes Society 2010 (hereafter, the organizer) concerning safety, management and implementation of the event and if the organizer deems it necessary to cancel participation to abide by the organizer's decision.
3. Accept emergency first aid in case of injury or accident during the event and absolve the organizer from any responsibility for the method, procedures, or any other aspect of first aid treatment.
4. Absolve the organizer from responsibility for any injury, illness, accident, loss of personal belongings, etc. that might occur during the Morning Run event and not to demand compensation for the same.
5. Accept that compensation for any accidents or injuries during the Morning Run event will be within the scope of the insurance policy carried by the organizer.
6. Declare that my family or relatives, and in the case of minors, my parent(s) or guardian, consent to my participation in this event.
7. Declare that all information provided in my application concerning age, gender, etc. is true and that no one but the applicant will participate in the event. If the organizer discovers any of the above to be false, I will obey the decisions of the organizer.
8. Consent to the use of any images, photos, articles, records, etc. (and the use of personal information such as my name, age, gender, image, etc.) for reports presented in newspapers, magazines and pamphlets or on the Internet, television, etc. I also accept that all rights for use of the same reside with the organizer.

The organizer will:

9. Judge whether to curtail or cancel the event and how to inform the participants in the event of a natural disaster, accident, epidemic, etc.
10. Strictly comply with all laws concerning the protection of individual privacy when handling information concerning the participants.
11. Not be held responsible in any way for first aid, etc. for participants who have falsified their application or who have replaced the original applicant.
